DISCUSSION	<b>Principal -</b>

Mr. Jackson provided a comprehensive report on staffing challenges, particularly in middle school, where he is working with district leadership on securing qualified teachers and addressing program continuity. The team discussed classroom assignments for next year, including moving Marina's dual-language first-grade class to a room with a bathroom and potentially relocating Ms. Metzler's classroom. The group also explored the implementation of the Six Pillars program school-wide and discussed the importance of maintaining consistent behavioral expectations across all grade levels. The conversation ended with a detailed explanation of the principal hiring process timeline, including the need to develop 10-12 interview questions and select an 8-person interview panel representing various demographics and roles within the school community.

**Parents** - The parent group reported updates on the financial status and upcoming events. They currently have \$1,008.52 in the bank. Recently spent \$460.00 for an after-school mariachi group attending to Mariachi conference. They are planning several activities, continuing to sell paletas after school and in games, and the Spring Fling event has moved to May 1st. The group discussed the need for volunteers and donations for these events. They also ordered 50 more shirts that were \$407.67. Also support OMA class supplies with \$59.06. We earned \$112.51 from Peter Piper Pizza.
